ADOPTION OF BOARD OF EDUCATION AGENDA: A motion was made by **Lower** and seconded by **Sturtevant** to approve the agenda as adjusted. Roll call vote showed Heeren, Lower, Snider, Sturtevant and Woessner voting aye. **Motion carried.**

CONSENSUS ITEMS:

A motion was made by **Sturtevant** and seconded by **Heeren** to accept the consensus items as presented:

- Minutes of the January 15, 2014 Regular Board of Education Meeting and March 21, 2012 Executive Session, per statute;
- Payment of Accounts Payable for the month of February, 2014;
- Approve the School Treasurer's Report for the month of January, 2014;
- FFA field trip request for March 7
- Review of student suspensions

Roll call vote showed Heeren, Lower, Snider, Sturtevant and Woessner voting aye. Motion carried.

BOARD INPUT:

Superintendent Hansen shared information on the Spring Dinner Meeting of the Illinois Association of School Boards on March 4th and brochures on the 1% School Facilities Sales Tax. He asked the Board for input into policy regarding use of school facilities by non-school groups, both for-profit and not-for profit. The policy committee will bring a recommendation back to the Board.

RECOGNITION OF VISITORS:

Parent Jennifer DeMichele addressed the Board of Education regarding the out-of-country educational trip to Costa Rica scheduled for the summer of 2015. She spoke of her recent trip to the country, and wanted the members to be aware that laws there are more lax. She also explained that the language barrier can be significant in that many of the people do not speak or understand English. The board members thanked her for sharing her experiences and concerns.

OLD BUSINESS:

> AD HOC COMMITTEE ON SCHOOL SECURITY UPDATE:

The Board heard an update on progress made in implementing recommendations of the Ad Hoc Committee on School Security.

A motion was made by <u>Lower</u> and seconded by <u>Snider</u> to approve the bid from <u>Aero Computing</u>, <u>LTD</u> for \$77,783.86 for the purchase and installation of high definition security cameras in the Eastland Elementary and Jr./Sr. High Schools. Roll call vote showed Heeren, Lower, Snider, Sturtevant and Woessner voting aye. <u>Motion carried</u>.

The Board tabled a decision on purchasing smartphones and service agreements for specific administrators and staff members until the Policy Committee has considered rules or regulations that might be necessary. The Board also wants to consider whether the purchase is necessary and appropriate, and asked for information on what other districts do with regard to issuance of cell phones.

> APPROVAL OF SCHOOL CALENDAR:

A motion was made by <u>Woessner</u> and seconded by <u>Lower</u> to approve amending the 2013-14 school calendar to request "Act of God" days for snow days taken on January 28th and February 5th and directed Superintendent Hansen to prepare a calendar for approval in March for the 2014-15 school year with 10 emergency days. > APPROVAL TO LET BIDS FOR BUSES:
