OLD BUSINESS:

> <u>REPORT ON SUMMER READING PROGRAM:</u>

Principal Mahoney updated members on the K-2 summer reading program. Twelve (12) students in grades K-2 will be attending the program for four hours/day, five days/week, July 5-August 4. Three (3) Eastland teachers will be developing and implementing the program designed to improve the reading proficiency of struggling readers. Bus transportation will be provided and parents will be working with their students to support the goals of the program.

<u>REPORT ON STATE PAYMENTS:</u>

Dr. Hansen reported on unrealized State revenues and their impact on the District's budget for 2016-17. State Comptroller Susan Mendoza testified last week that Illinois schools should not expect the remainder of their mandated categorical payments for the 2016-17 school year. Superintendent Hansen reported that for Eastland, this will amount to:

-\$86,000 of revenue to the Education Fund -\$180,000 of revenue to the Transportation Fund
